

Dear students.

Since 2019, some of you studying in UTT for incoming mobilities have to pay for scolarity fees.

For information, these fees cost €3770 for the master degrees in the year 2019/2020- non scolarity fees cost €243. For students in bachelor degrees, the scolarity fees cost €2770-non scolarity fees for engineering degrees cost €610.

According to established regulations, the fees would not change for the year 2020/2021.

In all cases, you will have to pay €92 for the CVEC (Contribution for student's life on campus).

If you come from one of the following countries, you can benefit from the procedure études en France: Algeria, Argentina, Benin, Brazil, Burkina Faso, Burundi, Cameroon, Chile, China, Colombia, Comoros, Congo-Brazaville, South Korea, Cote d'Ivoire, Djibouti, Egypt, United States of America, Gabon, Guinea, Haiti, India, Indonesia, Iran, Japan, Kuwait, Lebanon, Madagascar, Mali, Morocco, Mauritius, Mauritania, Mexico, Nigeria, Peru, Democratic Republic of the Congo, Russia, Senegal, Singapore, Taiwan, Togo, Tunisia, Turkey and Vietnam.

Fees and exemption from scolarity fees for international students

1) You are from a country of the European Union, of the European Economic Area, from Switzerland or Quebec

You do not have to pay for scolarity fees but for the same fees as students coming from a country of the European Union.

2) You had a residential status in France or in the European Union

You do not have to pay for scolarity fees but for the same fees as students coming from a country of the European Union.

3) You hold a scholarship from the French government

You are exempted from registration fees

4) You were registered before the academic year 2019 in a French institution granting a national higher education diploma

You do not have to pay for scolarity fees.





5) You are a refugee or you benefit from a subsidiary protection

You are exempted from subscription fees

6) You are registered in UTT in the context of an agreement with you home institution mentioning the exemption of fees

You are not in the case of benefiting from scolarity fees.

7) For the students who are in other cases, a commission can decide to allocate them an exemption of scolarity fees depending on the criteria set by the board of directors of UTT, especially for the students who have financial difficulties. Furthermore, the commission will prioritize the students with outstanding academic records and individual careers who are not eligible for the procedure études en France.

You can send an application for an exemption of scolarity fees until <u>July 3rd 2020</u> with the following supporting documents at ales@utt.fr:

- A motivation letter
- -Your academic results
- All the documents certifying your financial situation (notice of assessment, remuneration statement, rent receipt...)

The exemption of scolarity fees is attributed depending on your situation.

Furthermore, if you already confirmed your admission but you would like to cancel the procedure, please inform us by return e-mail.
