Hello,

Since 2019, some international students are subject to differentiated registration fees.

For information, these differentiated registration fees are, **for courses at bac+2 level and more**, €3,770 for the year 2023-2024 (the non-differentiated registration fees are €601 in engineering cycle and €243 in master).

For **general baccalaureate level courses, bac+1**, the differentiated registration fees are €2,770 for the year 2023-2024 (the non-differentiated registration fees for integrated preparatory cycle courses are also €601).

According to current regulations, they remain unchanged for 2023/2024. In any case, you will have to pay in addition to the 100 € of the CVEC (Student Life and Campus Contribution).

If you are from Algeria, Argentina, Benin, Brazil, Burkina Faso, Burundi, Cameroon, Chile, China, Colombia, Comoros, Congo Brazzaville, South Korea, Côte d'Ivoire, Djibouti, Egypt, Gabon, Guinea, Haiti, India, Indonesia, Iran, Japan, Kuwait, Lebanon, Madagascar, Mali, Morocco, Mauritius, Mauritania, Mexico, Nigeria, Peru, Democratic Republic of the Congo, Russia, Senegal, Singapore, Taiwan, Togo, Tunisia, Turkey and Vietnam, you can create an application file for 2023/2024 exemption fees.

Registration fees for international students and procedures for exempting international students from differentiated registration fees

1. You are a student from the European Union, the European Economic Area, Switzerland and Quebec

Differentiated registration fees do not apply, you pay the same registration fees as students from an EU member country.

2. You were a resident of France or the European Union

Differentiated registration fees do not apply, you pay the same registration fees as students from an EU member country.







3. You are a French Government Fellow (BGF)

You are exempt from registration fees.

4. You were enrolled in a French institution delivering a national higher education diploma before the start of the 2019 academic year

You are not affected by differentiated registration fees.

5. You are a refugee or have subsidiary protection.

You are exempt from registration fees.

6. You are registered with UTT under an agreement with your home institution that provides for exemption from registration fees.

You are not affected by differentiated registration fees.

7. In other cases, the UTT has set up an exemption commission that may grant exemptions from differentiated registration fees, based on criteria defined by the board of directors of the institution, namely, students whose exceptional financial situation justifies it. In addition, the committee will be able to assess files and individual courses of remarkable academic character that are not concerned by the study procedure in France.

You must file an exemption application <u>before december 17, 2023</u>, at ales@utt.fr, with the following supporting documentation:

- A cover letter;
- Your academic results;
- Any evidence of your financial situation (tax notice, pay slip, rent receipt, etc.).

The exemption is not de jure.
