

Dear students,

Since 2019, some international students at UTT have been subject to international registration student fees.

For your information, these fees were €3,770 for master's degrees in 2019/2020 (national registration fees were €243). For students in the first two years of the engineering degree, the international registration fees were €2,770 in 2019-2020 (national registration fees were €610), and for students in the final 3 years of the engineering degree, the international registration fees were €3,770 (national registration fees were €610).

These fees will not change in 2020/2021.

In all cases, you will have to pay €2 for the **CVEC (Contribution for student's life on campus)**.

If you come from one of the following countries, you can benefit from [the procedure études en France](#) : Algeria, Argentina, Benin, Brazil, Burkina Faso, Burundi, Cameroon, Chile, China, Colombia, Comoros, Congo-Brazzaville, South Korea, Cote d'Ivoire, Djibouti, Egypt, United States of America, Gabon, Guinea, Haiti, India, Indonesia, Iran, Japan, Kuwait, Lebanon, Madagascar, Mali, Morocco, Mauritius, Mauritania, Mexico, Nigeria, Peru, Democratic Republic of the Congo, Russia, Senegal, Singapore, Taiwan, Togo, Tunisia, Turkey and Vietnam.

International or national registration fees

1) You are from a country of the European Union, the European Economic Area, Switzerland or Quebec

You are subject to national registration fees.

2) You had a residential status in France or in the European Union

You are subject to national registration fees.

3) You hold a scholarship from the French government

You do not have to pay any registration fees.



4) You were enrolled before the academic year 2019 in a French institution granting a national higher education diploma

You are subject to national registration fees.

5) You are a refugee or you benefit from a subsidiary protection

You do not have to pay any fees.

6) You are enrolled at UTT in the context of an agreement with your home institution, which states that registration fees are waived

You do not have to pay any fees

7) In all other cases, UTT has an exemption commission that can decide to waive the international fees, based on criteria set by the UTT board of Directors, especially for students who have a difficult financial situation. The commission will also assess applicants with remarkable academic records who are not concerned by the **études en France procedure.**

You can apply for international fees to be waived until **July 3rd 2020** with the following supporting documents at ales@utt.fr:

- A motivation letter

-Your academic results

- All documents certifying your financial situation (your parent's bank statements, pay slips, and federal tax statement, your rent receipts...)

The fee-waiver is not a right.
